Associated Risks:	<ol style="list-style-type: none"> 1. Potential for crush injuries 2. Fire or emergency resulting in need for evacuation or possibly resulting in panic 3. Prolonged queuing and/or crowding resulting in panic in children with SEN 4. Blocked emergency or egress routes 5. Flashing images and ripple effect lighting resulting in vertigo or photosensitive epileptic attack 6. Trips and/or falls on stairwells in galleries Potential for collision with display stands or members of the public
Controls:	<ol style="list-style-type: none"> 1. All education groups must be booked through the Education Group Booking Team to ensure appropriate pre-visit briefings and safety instructions (including online risk assessment) received by lead teacher. 2. School to be met at entrance and VE crew on hand to assist. 3. Teacher recce visits offered where SEN should be discussed and issues indicated to teacher 4. Booking form to include question regarding pupils with SENs in the group 5. Pupils must be supervised by accompanying adults at ALL times. 6. Groups with more than 32 pupils must be subdivided and enter in over 2 time slots 7. Teacher to pupil ration must be strictly adhered to (1 accompanying adult to every 15 pupils or part thereof) 8. Minimum number of 2 accompanying adults per group (including subdivisions and regardless of groups having less than 15 pupils) must be adhered to. 9. Safety briefing for self-guided education groups must be included in the group welcome and delivered by BME crew before entering the experience. 10. General controls for galleries
